

## TELANGANA AS A SEPARATE STATE, THE ONLY SOLUTION

The situation post 09.12.2009 statement in Andhra Pradesh is a fraud on 4 crores of people of TELANGANA. Since 2001 during every election in A.P i.e from a village ward elections to General Elections, every single recognized party went on record begging votes predominantly on a sole issue of creating a separate state of TELANGANA. The merger of two unequals is itself unconstitutional, and against Art.14. Because of such untenable merger over the years the resources of the TELANGANA region are being looted like anything by the capitalists of SeemaAndhra. Its high time now such lootings ought to be curbed the only way out is by bifurcation of Andhra Pradesh into TELANGANA and SeemaAndhra. Apparently all other ways/options tried before have evolved no alternative solution. Because G.Os.(Government Orders) favouring TELANGANA region were never implemented in letter and spirit despite decades time has elapsed, Gentlemen's-Agreement was breached completely, Employment opportunities are being towed away and all the promises/conditions made during merger were proved to be air bubbles.

**“What TELANGANA region has been benefiting is so little when compared to loss suffered by it with the Merger of the state”.** Where as SeemaAndhra has been benefiting so unduly at the cost of TELANGANA, that is the reason why they (SeemaAndhra) want to have a 'Samaikya Andhra Pradesh' so that they can loot the Booty of natural resources, wealth, employment opportunities of TELANGANA Region all along as long as the Conspiracy called Andhra Pradesh existed.

The merger of Andhra Pradesh is totally wrong because it's proved by following prima facie differences;
